SECTION 7: HANDLING AND STORAGE

Requirements relating to storage premises apply to all facilities where the mixture is handled.

Avoid exposure to pregnant women and warn women of child-bearing age of the possible risks

7.1. Precautions for safe handling

Always wash hands after handling.

Remove and wash contaminated clothing before re-using.
